President Haidle provided the opportunity for public comment. No comment was given.


Superintendent Koehler shared gratitude toward this month's Leading Learning award recipients. The start of the school year began with inclement weather that caused several IT related issues. Our team responded immediately and had technology back up and running allowing students to return to the classroom sooner than anticipated.


The MI Student Voice website will be shared with superintendents from across the state at this week's Michigan Association of Superintendents & Administrators Conference. Currently, 58 districts statewide have administered the MI Student Voice Perception Survey, capturing the voices of 33,366 students. We expect this number to double over the next year, which will provide valuable data on student's educational experience.

Kent ISD was awarded the opportunity to lead a regional initiative to raise the level of post-secondary attainment in Kent County to 60 percent of residents holding a college degree, associates or workplace credential. This initiative was brought to us by the state of Michigan and the county administrator's office through the Governor's 60x30 initiative. This work directly aligns with Careerprep2030 and our work with the College Board this past year to bring AP courses to a larger percentage of students.
