### RECOMMENDATION:

It is recommended that the Kent ISD board approve renovations to the Educational Service Center in the amount of \$4,836,090, authorizing Owen-Ames-Kimball Co. to issue Notice of Pending Awards on behalf of Kent Intermediate School District, in the amount indicated in the award summary, pending confirmation that all requirements of the Contract Document have been met.

### BACKGROUND:

Renovations to the ESC will help meet the needs of a growing number of staff in the building. Human Resources, Security, ITDS, Communications, Student Services, and Instructional Services will all receive increased office space. Additionally, the Human Resources department will be strategically positioned closer to the main entrance. Renovations also include flexible conference space, updated ADA compliant restrooms, and private spaces for fingerprinting and onboarding.

Projected construction budget for this renovation was originally \$5,406,456. Recommended budget is \$570,366 under Design Development Budget.

Preparation for phase one will begin November 11, moving staff into temporary working space in the existing conference center space.

Planning for this project has involved program directors and staff from impacted departments. All three capital outlay funds will be used to fund this work.

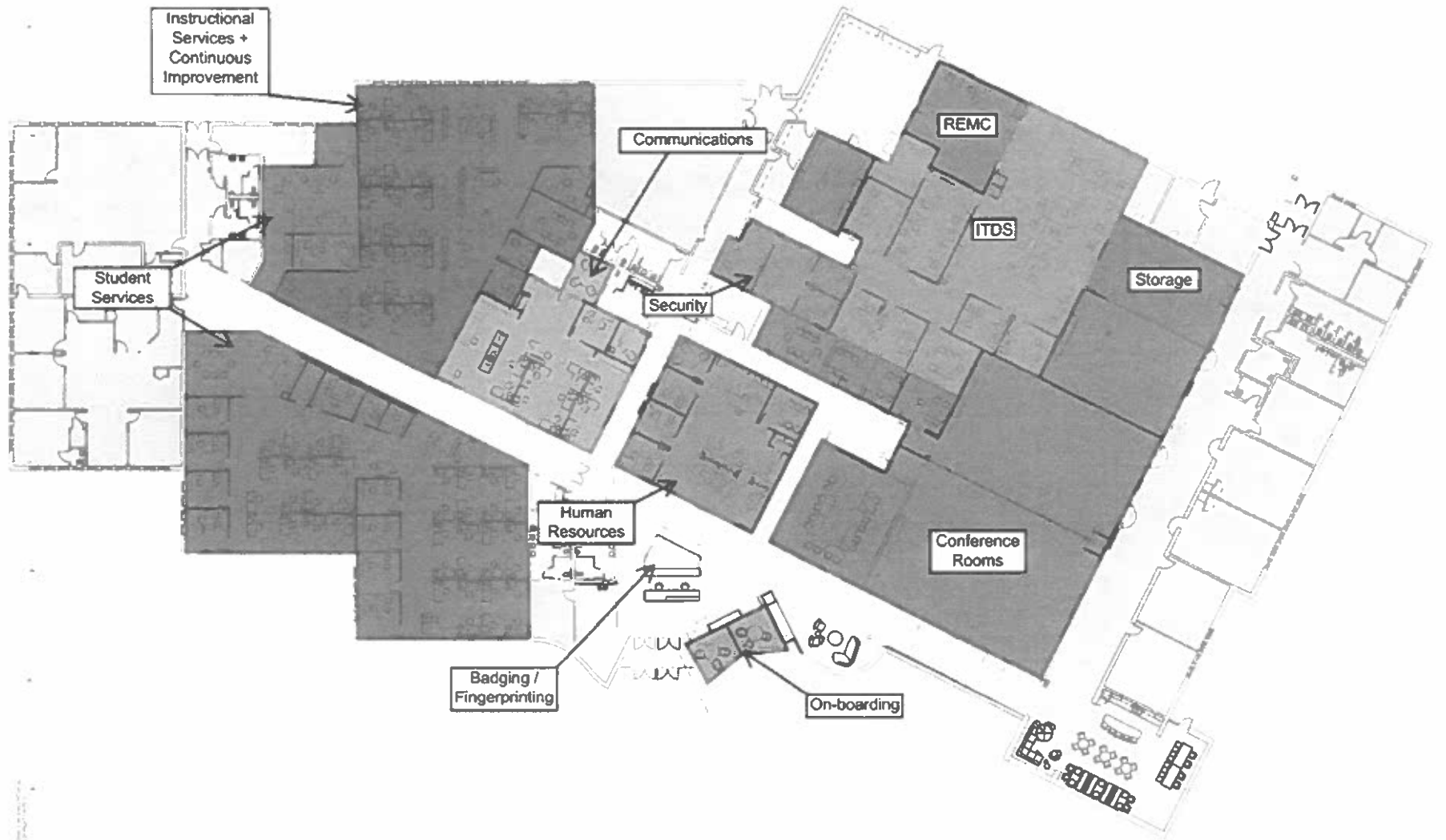
